Sub: Sports – TANGEDCO – Zonal Incharge &
Circle Sports Incharge – Nomination –
Certain instructions – Issued.

In partial modification of the orders issued at Item No.II of the Memo cited, the following orders are issued:-

2. The norms for nomination of Zonal Incharges and Circle Sports Incharges is as follows:-

ZONAL INCHARGES:

- i. He/She should have represented the TANGEDCO/TNEB Teams in any one of the games concerned and should be having adequate knowledge in all the games.
- ii. He/She should have adequate knowledge in conducting the sports activities and look after all the preliminary arrangements before conducting of the Inter Zonal Tournaments/AIESCB Tournaments as and when allotted to his zone.

CIRCLE SPORTS INCHARGES:

- i. He/She should have represented the TANGEDCO/TNEB Teams in any one of the games concerned and should be having adequate knowledge in all the games.
- ii. He/She should have adequate knowledge in conducting the sports activities.
- iii. In case no employee who has represented the TANGEDCO/TNEB Teams available in the Circles, then any employee who has represented in the Inter Zonal Tournaments may be nominated as Circle Sports Incharges.

3. The Secretary/TANGEDCO Sports & Games Committee will recommend the eligible employees for nomination of Zonal Incharges & Circle Sports Incharges and the President/TANGEDCO Sports & Games Committee will approve the recommendation of the Secretary/TANGEDCO Sports & Games Committee. The nominated Zonal Incharges & Circle Sports Incharges will look after the Zonal sports activities for only one year. In case, any Zonal Incharges/Circle Sports Incharges are not following the instructions issued by the Chairman-cum-Managing Director they will be removed from the post immediately. On completion of one year from the date of their nomination as Zonal Incharges/Circle Sports Incharges, the Secretary/TANGEDCO Sports & Games Committee will again recommend for the continuance (or) for change of Zonal Incharges and Circle Sports Incharges.

4. The following instructions are issued for conducting of Circle/Zonal Selections and Inter Zonal Tournaments:-

- i. Only the Circle Sports Incharges are permitted to conduct the Circle Selections.
- ii. Only the concerned Zonal Incharges of the zones alongwith Circle Sports Incharges of the zone are permitted to conduct the Zonal Selections. In addition to this, one player in the games concerned may be permitted to act as selector to attend the zonal selections in the games concerned. Only 10 Committee Members are allowed to assist the Zonal/Circle Incharges for conducting the Zonal Selections. The selectors and committee members should be got approved by the concerned CE's and the Secretary/TANGEDCO Sports Games Committee before conducting of the Zonal Selections. The above instructions should be followed very strictly.
- iii. For conducting the Inter Zonal Tournaments, the instructions issued by the Chairman-cum-Managing Director has to be followed very strictly. The selectors for selecting the TANGEDCO Teams will be issued by the Sports Section. Only 20 Committee Members are allowed to assist the Zonal Incharges for conducting the Inter Zonal Tournaments with the approval of the concerned CE's and the Secretary/TANGEDCO Sports & Games Committee before conducting of the Inter Zonal Tournaments. No other employees are permitted to

attend the Inter Zonal Tournaments and this should be followed very strictly. If any Zonal Incharges or Circle Sports Incharges are violating the above, they will be removed from the post immediately.

5. The receipt of the Memo. shall be acknowledged.
