**PROCEEDINGS**

As per Rule 1 of the Rules to regulate grant of Advance to TNEB Employees for building etc., of houses, read with Tamil Nadu Electricity (Reforms & Reorganization) Transfer Scheme 2010. House Building Advance may be sanctioned to employees, whether permanent or non-permanent, if they have rendered, on the date of application for the advance, six years continuous regular service.

2. In the Proceedings first read above, orders were issued taking into account of the period of service rendered as Helper (Trainee) and Office Helper (Trainee), while according sanction to the officials, in respect of House Building Advance, Conveyance Advance, etc.

3. The Government in their orders second read above, have reduced the eligibility criteria for sanction of loan towards House Building Advance, from the prevailing six years to a period of four years. The Board after careful examination, has decided to adopt the orders of the Government.

4. Accordingly, in exercise of the powers conferred by section 79(c) of the Electricity (supply) Act, 1948 (Central Act 54 of 1948) read with the said Transfer Scheme 2010, the TANGEDCO hereby incorporating the following amendments to Rule.1 of Tamil Nadu Electricity Board, Rules to regulate the grant of advance to employees towards House Building Advance:-

**AMENDMENT**

For the existing Rule (1) of the Rules to Regulate the Grant of Advances to Tamil Nadu Electricity Board Employees for Building Etc., of Houses read with Tamil Nadu Electricity (Reforms & Reorganization) Transfer Scheme 2010, the following shall be substituted:-

"House Building Advance may be sanctioned to the Tamil Nadu Electricity Board Employees, whether permanent or non permanent, if they have rendered on the date of application for advance 4 (four) years continuous regular service and their probation has been declared as satisfactorily completed in the post of their entry into service."

5. The receipt of the Proceedings shall be acknowledged.


