In the reference fifth cited, the Secretary to Government, P&AR (A), Department, Secretariat, Chennai, has stated that the Government of Tamil Nadu have issued orders/instructions to all Heads of Departments so as to emphasize that all the Government Servant, shall wear photo identity card compulsorily during office hours without fail. Even though orders/instructions have been issued, it is learnt that some of the departments have not followed the instructions scrupulously.

- 2. The Hon'ble High Court of Madras in its Judgment dated 16.07.2018 in W.P. No.15640/2018, has directed to ensure that all officers and employees of the Government of Tamil Nadu, particularly, those dealing with the public are provided with photo identity card, within 60 days from date, if the same has not already been done and also ensure that rule regarding wearing of photo identity cards is strictly enforced and action should be taken against those flouting the rules. Hence, requested all the Head of Departments/District Collectors to issue necessary instructions to wear photo identity card without fail during office hours by the employees.
- 3. In the references first to fourth cited various instructions were issued to employees of the erstwhile TNEB, now TANGEDCO/TANTRANSCO/TNEB Ltd. to produce the identity card as and when requested by the security officers.

- 4. In view of the Hon'ble High Court of Madras judgment, all the Chief Engineers/Superintending Engineers/Head of Departments are hereby directed to give suitable instructions to the sub-ordinate officers under their control to instruct all employees to wear photo identity card during office hours without fail.
  - 5. The above instructions should be adhered to strictly.
  - 6. The receipt of this memorandum should be acknowledged.
