PROCEEDINGS:

During the Wage Revision and Revision of Work allocation and Staff pattern negotiation meeting with the Management, the Unions have represented to create 43 posts of Senior Assessment Officer by duly abolishing the existing Assessment Officer posts in Distribution Circle Offices.

2) The representation of the Unions has been examined and the Board has approved for creation of 43 posts of Senior Assessment Officer by duly abolishing the existing 43 posts of Assessment Officer in Distribution Circle Offices.

3) Accordingly, it is ordered for creation of 43 posts of Senior Assessment Officer in the level 4 of revised pay of Rs.58,500 – 1,85,800 by duly abolishing the existing 43 posts of Assessment Officer in Distribution Circle Offices (except the newly formed Palladam EDC) for a period of one year from the date of utilization of the posts.

4) The Incumbents of the created posts will be eligible to draw the Usual Pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance, etc., at the rates as admissible under the orders in force wherever applicable.

5) The Superintending Engineers concerned shall report the actual date of utilisation/ abolition of the posts as ordered in Para (3) above promptly.

6) The expenditure is debitable to "TANGEDCO Funds - Revenue Expenses - 75 - Employees Costs 75.1-Salaries -75.110-Salaries Provincial."

7) Receipt of the TANGEDCO Proceedings shall be acknowledged.
