Ref: CE/P discussion with Engineers' Sangam on 23.02.2016 and CMD approved Minutes communicated dt.24.02.2016.

Engineers' Sangam representing for creation of Technical Assistant / Civil post to accommodate Diploma qualified civil employees working in TANGEDCO through Internal Selection method.

Moreover for Junior Engineer Grade-II / Civil and Junior Engineer Grade-I / Civil post Technical Assistant / Civil is the feeder category. Apart from that, we have already submitted a list of persons in RWE category who have completed Diploma in Civil working in various other category got promotion in RWE cadre without considering their acquired qualification.

The above grievance has been presented in discussion on promotional Avenue in Hydro Stations held during 2013, it was taken note that nearly 100 plus qualified Civil diploma holders are working without having proper promotion in accordance with the qualification acquired. They have been accommodated in RWE post and promotion without considering their qualification since the post of Technical Assistant / Civil are not created, though the demand is pending for long time.

The same was represented to the Chief Engineer / Personnel during discussion on 23.02.2016. During discussion the Chief Engineer / Personnel assured us that;

"to ascertain the number of Civil / Sub-divisions and number of Pole Casting yards in Distribution circles and other areas, the details will be called for and on receipt of the same, recommendation will be made for implementation."

The respected Chairman cum Managing Director / TANGEDCO approved minutes is also communicated to us on 24.02.2016.

Hence, we humbly request the Respected Chairman cum Managing Director / TANGEDCO to instruct the Chief Engineer / Personnel to call the due particulars from field for early implementation "creation of Technical Assistant / Civil post" one of our agreed demands which was pending.
