In the reference 1 & 2 cited, the tentative Inter-se-seniority list of 393 & 1364 Junior Engineer/Electrical – II Grade were issued with a intimation to submit objections within one month from the date of issue of such tentative inter-se-seniority.

2. Thiru M.Vetrivelu, Junior Engineer/Elecl.-I Grade has filed WA (MD) No.1227 of 2018 with a prayer to set aside the order passed by this Court in W.P. (MD) No.20174 of 2015, dated 25.07.2015.

The Hon'ble Madurai Bench of Madras High Court in its order dated 02.07.2019 made in the above Writ Appeal has directed that the affected persons to make their objection as against the tentative list published on 22.11.2018 and 08.11.2018 within a period of three weeks from the date of receipt of a copy of this order. On receipt of such objections the authority concerned shall consider such objections and prepare a final list accordingly and publish the same within a period of four weeks.

4. Hence, all the Chief Engineers/Superintending Engineers are requested to make necessary arrangements to make wide publicity of this order with a direction to submit any objections of JE/Elecl.-II Grade who have been affected on release of the two tentative inter-se-seniority list issued vide reference 1 & 2 cited, before 20.08.2019 to the officer concerned, and in turn, the objection if any received may be sent to this office before 27.08.2019 so as to prepare a final inter-se-seniority list and to publish.
