In the reference fifth cited, the Secretary to Government, P&AR (A), Department, Secretariat, Chennai has stated that the Government of Tamil Nadu have issued orders/instructions to all Heads of Departments so as to emphasize that all the Government Servants, shall wear photo identity card compulsorily during office hours without fail. - 3. It is therefore, instructed that all the officers/staff of TANGEDCO/TANTRANSCO/TNEB Ltd. should compulsorily wear the Identity Card without fail.
 - 4. The above instructions should be adhered strictly.
 - 5. The receipt of Memorandum should be acknowledged.
