PROCEEDINGS

In the Proceedings read above, orders have been issued for creation of 5000 new posts of Gangman in the level of pay of 16,200-51,500 in Regular Work Establishment category (Class-IV service) in TANGEDCO for a period from the date of utilization of the posts upto 28.02.2020, for attending the works specified therein. They would be considered for promotion to the post of Senior Gangman and Chief Gangman in the pay level of Rs.18,800-59,900 and 19,500-62,000 respectively. Therefore the proposal for making amendment to Tamil Nadu Electricity Board Service Regulations has been considered and approved by the Board of TANGEDCO.

2. Accordingly, in exercise of the powers conferred by Section 79 (c) of the Electricity (Supply) Act, 1948 (Central Act 54 of 1948), read with Section 185 of the Electricity (Supply) Act, 2003 and G.O.Ms.No.100 Energy (B2) Department, dated 19.10.2010, the Tamil Nadu Generation and Distribution Corporation Limited (formerly Tamil Nadu Electricity Board) makes the following amendments to the Tamil Nadu Electricity Board Service Regulations:-

(c) <u>GANGMAN:</u> Every Gangman recruited direct shall be on training for a period of two years under the respective offices. During the

period of training, he shall draw consolidated pay at Rs.15,000/per month. The period of training shall not count for probation or increment in the post of Gangman.
