The attention of all the Superintending Engineers is drawn to the references (1) and (2) cited above, wherein the Suitability report, Service Particulars & DP/DVAC particulars of Assistant Engineers/Elecl., Junior Engineers/Elecl. I Grade and CHD were called for, for preparation of panel for promotion to the post of Assistant Executive Engineer/ Electrical.

(6) If the confirmation report (i.e.) Annexure – B is not signed by the concerned Superintending Engineer or submitted to this office on or before 15.05.2019, even then it will be considered that the concerned Superintending Engineer has agreed and confirmed to all the instructions issued vide this letter and its enclosures.
