PROCEEDINGS:

The Government in the G.O. read above, have issued orders recognizing certain National Trade Certificates in trades under the "Centre of Excellence Scheme (i.e. Broad Based Basic Training (BBBT) + Advance Modules Training)" as equivalent to the "National Trade Certificate/National Apprenticeship Certificate in conventional Trades under Craftsmen Training Scheme" for the purpose of employment to suitable posts under Government Departments. Out of various trades mentioned in the said Government Order, (i) Production and Manufacturing; (ii) Fabrication, Fitting and Welding; and (iii) Electrical alone are related to TANGEDCO, which have been recognized by the Government as equivalent to Welder/Machinist, Welder and Electrician respectively. It has been proposed to include the said three Centre of Excellence Trades in the TNEB Service Regulations apart from the existing 13 Conventional Trades, so as to enable the candidates possessing the said qualifications to become eligible for appointment to the post of Helper/Field Assistant, by partially adopting the G.O. read above. Therefore, a proposal for making amendment to the TNEB Service Regulations by adopting the G.O. read above, has been placed before the Board of TANGEDCO and after careful consideration, the Board of TANGEDCO has approved the same.

2. Accordingly, in exercise of the powers conferred by Section 79(c) of the Electricity (Supply) Act, 1948 (Central Act 54 of 1948), read with Section 185 of the Electricity (Supply) Act, 2003 and G.O.Ms.No.100, Energy (B2) Department, dated 19.10.2010, the Tamil Nadu Generation and Distribution Corporation Limited (formerly

Tamil Nadu Electricity Board) makes the following amendment to the Tamil Nadu Electricity Board Service Regulations:-

AMENDMENT

In the said Regulations, in Annexure III (referred to in regulation 94), for the expression "Helper" in column (1) and its corresponding expressions in columns (2) & (3), the following expressions shall be substituted:

"Helper/ Field Assistant	<p>Must possess National Trade Certificate / National Apprenticeship Certificate awarded by the National Council for Training and Vocational Trade in any one of the following Trades:</p> <p><u>Conventional Trades:</u></p> <ol style="list-style-type: none">1. Fitter2. Turner3. Machinist4. Welder5. Wireman6. Building Constructor7. Blacksmith8. Carpenter9. Plumber10. Electrician11. Instrument Mechanic12. Draughtsman (Civil)13. Surveyor <p><u>Trades under Centre of Excellence Scheme:</u></p> <ol style="list-style-type: none">1. Production & Manufacturing2. Fabrication, Fitting & Welding3. Electrical <p>Provided that the Chairman shall have the power, to order the selection from any of the Trades referred to above and to such number as may be decided by him".</p>


