The individuals mentioned in the Annexure to this reference whose names have been approved for appointment as Junior Assistant (Accounts) by Internal Selection and whose particulars are furnished against their names, are allotted to your circle issuing orders for appointment as Junior Assistant (Accounts) on temporary basis in the minimum of the time scale pay of Rs.19,500 – Rs.62,000 with usual allowance admissible as per rules, subject to protection of loss of pay, if any by grant of personal pay.

- 2) It is requested you to issue appointment and postings orders to the individuals through the Superintending Engineers concerned directing them to report for duty on expiry of joining time, failing which their names will be removed from the selected list.
- 3) In the appointment orders, it may be indicated specifically that their appointments are subject to the following conditions:
 - i) Their pay will be fixed by grant of Personal Pay to the extent of the difference in the basic pay admissible to them from time to time in the post of Junior Assistant (Accounts) becomes equal to or more than basic pay in the previous post or by promotion to higher post whichever is earlier as per orders in B.P.Ms.(FB) No.95, (Sect.Br.) dated 20.11.1985

- ii) The employees are not eligible for fixation of pay under Regulation 33(b) of TNEB Service Regulation since the appointment is now ordered by internal selection.
- iii) The employees may be informed that, the representation for changing of posting or extension of time to join duty will be not entertained.
- iv) They should produce satisfactory evidence in original regarding their educational qualification, date of birth and community before joining and if any discrepancy is found in the certificates or if they are found to be unqualified, their appointments will be cancelled immediately and cancellation of selection also.
- v) Those who do not possess adequate knowledge in Tamil (i.e. S.S.L.C. Standard) should pass second class Language Test conducted by the T.N.P.S.C within the prescribed period.
- vi) They should relinquish their rights for further promotion in the post last held in the event of their appointment as Junior Assistant (Accounts).
- vii) They will not eligible for reversion to their parent categories of posts under any circumstances.
- 4) An undertaking to the effect of item Nos. (i), (v) and (vi) mentioned in para 2 above may be obtained from the individual's (in duplicate) before their joining as Junior Assistant/Accounts. One copy of the undertaking should be pasted in Service Roll/ Service Book of the individuals concerned and another copy should be retained in the office of the Superintending Engineer.
- 5) The Superintending Engineers are also requested to send a prescribed form of Physical Fitness Certificate to the individuals along with orders of appointment and directing them to produce the same duly filled and attested by a Government Medical Officer in the rank of Civil Assistant Surgeon at the time of joining duty. The Physical Fitness Certificate can be scrutinized by the Superintending Engineers concerned and the service of individual may be regularized with reference to the instructions in Administrative Branch Memorandum No.134730/P.II(1)/85-1, dt. 20.12.1985. The copy of appointment orders issued to the individuals should be sent to this office, without fail.

- 6) The Superintending Engineers are informed that in the case of individual against whom D.P.s are pending (or) if the individuals are undergoing punishment (or) Possessing Diploma/ITI (NTC/NAC) qualification, orders of appointment and postings need not be issued to them and the fact may be reported to this office.
- 7) The officers may be requested to fix the last date for joining duty and if they do not join duty on or before that date, the selection will be cancelled.
 - 8) The date of joining of those candidates should be reported promptly.
 - 9) The receipt of this letter may be acknowledged.
