PENSION – Dearness Allowance to Pensioners and Family Pensioners Revised rate of Dearness Allowance from 1st July, 2019 – Orders - Issued.

PROCEEDINGS:

In the Proceedings first read above, among other things, orders were issued allowing 12% of Dearness Allowance to the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited with effect from 01.01.2019. In the Government Order second read above, orders were issued revising the rate of Dearness Allowance from **12% to 17%**, payable to the Pensioners/Family Pensioners with effect from **1st July, 2019**. It has been decided to extend the same benefit to the Pensioners/ Family Pensioners of TANGEDCO.

2. Accordingly, it is hereby ordered that the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited, be paid Dearness Allowance with effect from **1st July, 2019** at the following rates:-

Date from which payable	Revised rate of Dearness Allowance (per month)
1st July, 2019	17% of Basic Pension/Family Pension.

3. Consequent on increase in the rate of Dearness Allowance from **12% to 17%**, the arrears for the period from **01.07.2019 to 30.09.2019**, as ordered in para-2 above, shall be paid to the Pensioners/Family Pensioners along with the Pension/Family Pension for the month of **October 2019**.

4. The amount of Dearness allowance involving a fraction of a rupee shall be rounded off to the next higher rupee, if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

5. In the case of divisible Family Pension, the Dearness Allowance shall also be paid proportionately.

6. The receipt of these proceedings shall be acknowledged.


