It has been brought to the notice that based on the letter given by a rival group to stop deduction of Union donation from the members of Tamil Nadu Electricity Board Engineers Sangam, the Union donation was not deducted from the salary of the employees for the month of November 2012 payable in December 2012 in some of the offices. Now, the Hon'ble High Court by its interim injunction order dt.8-1-2013 restrained the rival group to function as the office bearers of Tamil Nadu Electricity Board Engineers Sangam. Hence, all the Chief Engineers/ Superintending Engineers and other Officers are requested to deduct the annual donation from the members of Tamil Nadu Electricity Board Engineers' Sangam from the pay bill for May 2013 payable in June 2013 in respect of those officials who have already exercised their willingness to deduct the annual donation to the said Sangam provided that the annual donation for the year 2012 was not deducted from the pay as per the orders issued in Board's Proceedings first cited.
