Sub: Filling up of vacancies of Assistant Engineer / Electrical / Mechanical And Civil – by Internal Selection – abnormal delay – intervention of CMD – requested – Reg.

We invite the kind attention of the respected Chairman cum Managing Director on the following few lines;

- There are two channels for filling up the posts of Assistant Engineer one by Internal Selection among existing employees who works in T.N.E.B. and qualified Degree in Engineering and the other by Direct recruitment from external sources who does not have the work experience and not working in T.N.E.B.
- The Board is maintaining the ratio of 1:1 among internal selection and direct recruitment and their seniority is fixed as per the calendar year (i.e. on 31st December of every year).
- After consider the vacancies to be filled for the post of Assistant Engineer. Board called for particulars for the internal selection, from the eligible candidates who are working in T.N.E.B. vide reference (1), (2) and (3) for the categories of Assistant Engineer / Electrical, Mechanical and Civil respectively.

The call letter of the Chief Engineer / Personnel clearly states that "30.06.2015 is the last date for the employees to submit their application and 15.07.2015 is the last date for the field officer to submit the application to the office of the Chief Engineer / Personnel".

- Even though all the particulars were received at the office of the Chief Engineer / Personnel, no further action is taken to process the panel for approval and releasing appointment orders. Our repeated requests are in vain.
- It is the habitual practice of the personnel management to delay the process of Assistant Engineer / Internal Selection panels to give advantage to the Direct Recruitment candidates.

Though the personnel management actively processing for the Direct Recruitment, the process of completing the same before 31st December 2015 is not sure.

From the above, we apprehend, the personnel management is intentionally delaying the Assistant Engineer / Internal Selection panels for the past four months from 15.07.2015 so as to deny their legitate appointment as Assistant Engineer and their due seniority which has to be confirmed before 31.12.2015.

Also we learn that, the personnel management is citing a counter prepared by them stating that "the Internal Selection and Direct Recruitment will be made simultaneously".

It is the stand of the management in that particulars case to avoid adverse remarks from the court.

As for as this current panels are concerned there is no legal bar and the Service Regulation is very clear to process, finalise and release orders of appointment through internal selection. No where the word "simultaneous" finds place in these orders (or) regulations.

The candidates who works hard in the field, attending duties in shifts and odd hours and qualifies degree in Engineering in addition to their works.

The Board must fill up the vacancies first from the candidates who are its own employees and then to resort for the external recruitment which will help the Board financially as well as technically.
