Apart from the above, the personnel management is not taking any positive actions instead it is distorting and delaying the actions to favour the graduate engineers and the T.N.E.B. Engineers' Association in the following issues.

- 1. Assistant Executive Engineer / Non-Independent to Junior Engineer Gr.I.
- 2. a) Assistant Engineer / Electrical seniority (2005 & 2006 batches)
  - b) Calling for Assistant Executive Engineer / Electrical promotion.
- 3. Technical Assistant / Direct Recruitment (graduates case).

The State General Council and the Cabinet Meeting of our T.N.E.B. Engineers' Sangam discussed the issues in depth and recorded its protest against the personnel management for its continued biased actions against the welfare of diploma engineers including their legitimate and routine promotions, Internal Selections and Seniorities.

We would like to place it on records that the assurances given by the Chief Engineer / Personnel during our discussions and representations to implement the agreed demands are not honestly met with and the issues to which specific time frame given were also not implemented by the Chief Engineer / Personnel. In short the Chief Engineer / Personnel is carrying out unfair labour practices. This creates unrest among the Diploma Engineers which in turn will deteriorate the industrial peace that exists in this vital organization.

Hence, we request the kind and personnel attention of the Chairman cum Managing Director on the long pending issues and to direct the Chief Engineer / Personnel to clear all Promotions, Internal Selections, Seniorities and Court cases with immediate effect and to create confidence and conducive atmosphere to maintain good industrial relations.
