PROCEEDINGS:-

In the Proceedings second read above orders were issued enhancing the monetary limit/eligibility criteria to the regular employees of the Corporation for purchase of all categories of motorized Two Wheelers, for a maximum ceiling limit of Rs.50,000/- (Rupees fifty thousand only) and for purchase of new Motor Cars through conveyance advance as detailed below:-

Sl. No.	Eligibility (Revised Scale of Pay)	Quantum of advance
1.	Pay Band 4 and above	Rs. 6.00 Lakhs
2.	Pay Band 3	Rs. 5.00 Lakhs
3.	Below Pay Band 3 with Grade Pay of Rs.2900 and upto Grade Pay of Rs.4600/-	Rs.3.00 Lakhs

2. Orders were issued in the Proceedings third read above enhancing the Grade Pay of Rs.2700/- to Rs.2800/- in respect of the employees who are drawing their pay under Pay Band-1 with effect from 01.12.2011 and monetary benefit from 09.01.2014. Representation have been received for enhancement of ceiling limit by 5% over the previous years and to fix the Grade Pay of Rs.2800/- for availing conveyance advance as in Government orders first read above.

3. The Board has decided that

- (i) the ceiling of conveyance advance towards the purchase of Motor Cars and two wheelers be enhanced at the rate of 5% over the previous years notionally with effect from 2010-2011 and to extend monetary benefits from the year 2015-2016 prospectively as per the statement annexed.
- (ii) the benefits of availing conveyance advance be extended to the employees who are drawing their pay in Pay Band-1 with Grade Pay of Rs.2800/-.

4. The revised ceiling prescribed in the annexure will bear only prospective effect from the year 2015-2016. For every subsequent year, the sanctioning authorities are instructed to accord the enhanced sanction as in the Annexure at the rate of 5% over the previous years, until further orders.
