Sub: Revision of Pension/Family Pension relating to the employees who retired/died while in service before 01.12.2015 - Amendment - Issued.

In the reference cited, among others, the following orders have been issued :-

para 10(i) Pensioners/Family Pensioners upto 30th November, 2015 entitled to revision of Pension/Family Pension in terms of clause (II) of paragraph 3, such Pensioner/ Family Pensioner after re-fixation of Pension/Family Pension with reference to clause (I) of paragraph 3 of this order may apply to the Pension Sanctioning Authority concerned in the office in which the employee of TANGEDCO last served who is competent to process and forward pension proposal to the Chief Internal Audit Officer/Audit Branch in the prescribed form as at Annexure-I appended to this order in triplicate. The Pension Sanctioning Authority concerned shall revise both the Pension and Family Pension of the existing pensioner/family pensioner with reference to paragraph 3 of this order.

**para 10(ii)** In respect of Family Pensioners, even if they are unable to furnish all the particulars in the application form, the Pension Sanctioning Authority shall accept such applications and process with the available data.

**para 10(iii)** On receipt of application in triplicate, the competent authority shall verify the net qualifying service already certified at the time of initial sanction of pension. He shall fix the revised pension admissible with reference to minimum of the level pay or first Cell in the Pay Matrix relating to the post held by the pensioner at the time of retirement and net qualifying service in the application form itself. He shall also communicate copy of the statement to the pensioner/ family pensioner. The Chief Internal Audit Officer/Audit Branch shall verify the correctness of the revised pension and make payment as specified in paragraph-3 above after making necessary entries in records maintained in his office.

- 2. It has been brought to the notice that, the above process of furnishing the applications to the Pension Sanctioning Authorities and in turn forwarding the same to the Chief Internal Audit Officer/Audit Branch for authorization causes undue delay. The Pensioners' Association have, therefore, requested to issue modified instructions dispensing with submission of applications as ordered. The same has been examined and it has been decided to issue necessary amendment to this effect.
- 3. Accordingly, the following amendment is issued to (Per) CMD TANGEDCO Proceedings No.52, (SB) dated 02.03.2018:-

## <u>AMENDMENT</u>

For the expression in para 10 (i), (ii) and (iii), the following expression shall be substituted:-

para 10(i) Pensioners/Family Pensioners upto 30th November, 2015 entitled to revision of pension/family pension in terms of clause (II) of paragraph 3, such pensioners/family pensioners after re-fixation of pension/family pension with reference to clause (I) of paragraph 3 of this order may apply to the Chief Internal Audit Officer/Audit Branch in the prescribed form as at Annexure-I appended to this order in triplicate. The Chief Internal Audit Officer/Audit Branch shall revise both the pension and family pension of the existing pensioners/family pensioners with reference to paragraph 3 of this order.

**para 10(ii)** In respect of family pensioners, even if they are unable to furnish all the particulars in the application form, the Chief Internal Audit Officer/Audit Branch shall accept such applications and process with the available data.

**para 10(iii)** On receipt of application in triplicate, the Chief Internal Audit Officer/Audit Branch shall verify the net qualifying service already certified at the time of initial sanction of pension. He shall fix the revised pension admissible with reference to minimum of the level pay or first cell in the pay matrix relating to the post held by the pensioner at the time of retirement and net qualifying service in the application form itself. He shall also communicate a copy of the statement to the pensioner/family pensioner and make payment as specified in paragraph 3 above after making necessary entries in records maintained in his office.
