In the Board's Proceedings first cited, orders were issued for the norms to be adopted for sanctioning commissioning incentive. Accordingly the General Construction Circle Staff who were directly associated with the particular project during the period are entitled for the said incentive.

- 2. In the Board's Proceedings second cited, orders have been issued for sanction of commissioning incentive to the employees borne on the rolls of North Chennai Thermal Power Station Stage-II stationed at the Project site and were on duty for not less than 300 days, including holidays and casual leave but excluding other types of leave from the date of commencement of the project till the commissioning/inauguration of the project shall be eligible for the incentive.
- 3. The Chief Engineer/Transmission Projects-I/TANTRANSCO has submitted a proposal that the officers and staff of General Construction Circle were with full involvement and dedication have contributed their best efforts for successful commissioning of North Chennai Thermal Power Station Stage-II by creating 400 KV NCTPS Stage —II to Alamathi Sunguvarchatram 400 KV DC line for the evacuation of power generated at NCTPS Stage-II and for sanction of commissioning incentive to the 43 Officers and Staff on par with the employees of NCTPS-II. The proposal has been examined and accepted.

- 4. Accordingly, it is hereby ordered that the 43 Nos. officers and staff mentioned in the Annexure working in GCC Chennai be sanctioned and paid commissioning incentive of one month Pay + Dearness Allowance with 10% cut relating to the month of completion (May 2014) on par with the employees of North Chennai Thermal Power Station Stage-II.
