PROCEEDINGS:

1. The Quantum of works to be executed in respect of IPDS, DDUGJY and UDAY Schemes within stipulated time is voluminous and the materials to be procured are also huge in quantity. Superintending Engineer's/EDC have to float multiple tenders within the existing delegation of tender powers for procurement, which may warrant more time and leads to delay in completion (i.e. not within the target date) of the scheme works. Further, with enhanced monetary powers, the volume of procurement will be more and consequently better/competitive pricing can also be achieved.

2. The Tamil Nadu Generation and Distribution corporation Limited after careful consideration hereby delegates tender powers to SEs/EDCs towards procurements for scheme works viz.. IPDS, DDUGJY and UDAY Schemes by suitably amending the Table I (For of Procurement materials) (Open Tender) of Delegation of Tender Powers issued vide TANGEDCO (FB) B.P No. 05 dated 06-04-2017 as tabulated below:
