In the above letter, it has been requested to clarify the applicable tariff LT SC No:006-010-810-M/s.Saravana photo color Lab, Cuddalore Dist by enclosing relevant documents.

In this connection, it is informed as follows:

- 2.0 The Tariff Order issued by the Commission specifies the following in regard to application of LT Tariff III A (1) Cottage and Tiny industries:
- "6.2.9.2 This tariff is applicable to Cottage and tiny industries, Micro enterprises engaged in the manufacture or production of goods pertaining to any industries specified in the first schedule to Industries (Development and Regulations) Act 1951 (Central Act 65 of 1951).
- 6.2.9.3 The intending consumers applying for service connection under LT Tariff III A (1) claiming to have established the micro enterprise engaged in the manufacture or production of goods shall produce the cottage industries certificates from the industrial department /acknowledgement issued by the District Industries Centre under the Micro Small and Medium Enterprises Development Act, 2006 (Act 27 of 2006) as proof for having filed Entrepreneurs Memorandum for setting up of Micro Enterprises for manufacture or production of goods with District Industries Centre under whose jurisdiction the Enterprise is located"

- 3.0 As per the above provision, to avail service connection under LT tariff III A (1), the consumer has to produce the certificate from the industrial department /acknowledgement issued by the District Industries Centre under the Micro Small and Medium Enterprises Development Act, 2006 (Act 27 of 2006) as proof for having filed Entrepreneurs Memorandum for setting up of Micro Enterprises for manufacture or production of goods with District Industries Centre under whose jurisdiction the Enterprise is located and also that the industries should be specified in the first schedule to Industries (Development and Regulations) Act 1951 (Central Act 65 of 1951).
- 4.0 On Scrutinization of the documents, it is found that the photo colour labs (manufacturing of digital photos and frames) are not included in the First schedule to Industries (Development and Regulations) Act 1951 (Central Act 65 of 1951) (copy enclosed) and SE/Cuddalore EDC has requested to clarify from Department of Industries & Commerce (DIC) of Cuddalore District on what basis certificate issued to color lab even though the same is not included in that category and Department of Industries & Commerce (DIC)has informed that the Entrepreneur Memorandum Acknowledgement for the activity of Manufacturing of Digital Photos and Frames only vide this office(DIC Cuddalore Dist) Entrepreneur Memorandum No.33/018/12/0009 dated:04.05.2011 under Manufacturing activity **MSMED** as per Act 2006(dated:02.10.2006) without any proof to cover under first schedule to Industries (Development and Regulations) Act 1951 (Central Act 65 of 1951).
- 5.0 In the absence of photo color labs in the first schedule of Industries (Development and Regulations) Act 1951 (Central Act 65 of 1951), the tariff III A could not be adopted as per prevailing tariff order even though they submitted the certificates from Department of Industries and Commerce.
