PROCEEDINGS:-

In the Government Order second read above, approval has been accorded for creation of a new post of Director (Planning and Regulatory) in the Tamil Nadu Power Distribution Corporation Limited by surrendering one existing post of Chief Engineer, viz., Chief Engineer (Civil), Uppur Supercritical Thermal Power Project.

2. Accordingly, sanction is hereby accorded for creation of one post of Director (Planning and Regulatory) in the Level of Pay of Rs.1,27,400–2,23,300/- to the Office of the Tamil Nadu Power Distribution Corporation Limited, Chennai.

3. Consequent to the orders issued in para-2 above, one post of Chief Engineer, Civil, Uppur Supercritical Thermal Power Project (Position ID 54070001) last continued in the memorandum first read above, shall be abolished with effect from the date of utilization of the newly created post.

4. The incumbent of the post ordered in para-2 above will be eligible to draw the usual pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and other allowances at the rates admissible under the orders in force wherever applicable.
