Sub : TNPDCCL – Wearing of Photo Identity Cards compulsorily by the TNPDCCL, TNGECL, TNPGL, TANTRANSCO and TNEB Ltd. employees – Instructions – Reiterated – Orders - Issued.

In the reference first cited, the instructions were reiterated that all the Chief Engineers/Superintending Engineers, Heads of Office of Headquarters were directed to issue suitable instructions that the employees of TANGEDCO, TANTRANSCO and TNEB Ltd. to wear and display their Identify Cards visibly while entering into premises without fail. Further, as and when the security people ask the employee to show the Identity Cards, the employees should show without any hesitation.

2. The then Additional Director General of Police/Vigilance has accorded approval from the Chairman and Managing Director/TNPDCCL for reiteration of instructions issued wearing identity Cards visibly while entering into premises and during the office hours without fail. Hence, all the Chief Engineers/Superintending Engineers and Heads of Office of Head Quarters are hereby directed to issue suitable instructions that the employees of TNPDCCL, TNGECL, TNPGL, TANTRANSCO and TNEB Ltd to wear and display their Photo Identity Card's visibly while entering into premises and during the Office hours without fail. Further, as and when the Security people ask the employee to show the Identity Card and could identify the employees and outsiders, the employees should show without any hesitation.

3. The above instructions should be adhered strictly.
4. The receipt of Memorandum should be acknowledged.
