In the Proceedings 1<sup>st</sup> cited above the panel for the post of Assistant Executive Engineer/Electrical consisting of 185 individuals for the year 2023-2024 was approved and panel has been exhausted.

2. In the reference second cited, the suitability report/PAR called for from 833 Nos. as per estimated vacancies for the post of Assistant Executive Engineer/Electrical. The said post are very much required to maintain the uninterrupted power supply to the public. Hence it has been decided to fill up the existing vacancies by giving temporary promotion to the eligible individuals of the years 2010 & 2011 in the cadre of Assistant Engineers/ Electrical along with Junior Engineer/ Electrical I Grade and one Chief Head Draughtsman for the crucial date 05.08.2025 under regulation of 106 of the TNEB Service since, the Hon'ble High Court directed vide reference 3<sup>rd</sup> cited to refix the seniority as per merit to the year 2012 recruited Assistant Engineers/Electrical.

3. Accordingly, it has been found that the names of the following 117 Nos. individuals (1 Chief Head Draughtsman + 29 Junior Engineers/Elect.I Grade + 87 Assistant Engineers/Elec.) are eligible for the post of Assistant Executive Engineer/Electrical and temporary promotion and posting orders to the said 117 individuals are issued with effect from the date of assumption of charge under regulations 106 of TNEB Regulations.
