Further in Board Proceeding third cited, the quantum of subscription had been enhanced from Rs.40/- to Rs.60/- per month with effect from 1.6.2000. Thereafter in the Board Proceeding fourth cited, the subscription towards this scheme was further enhanced to Rs.70/- per month with effect from 1.2.2002.

- 2. The pensioners Associations have been insisting upon to extend the above scheme to the pensioners absorbed from Madurai (Metro), Coimbatore (Metro), Thanjavur, Karur and Pollachi Electrical Undertaking retired before vesting date. The said request of the Pensioners' Associations has been considered in detail.
- 3. Accordingly, the Tamil Nadu Electricity Board directs that the Pensioners' Family Security Fund Scheme be made applicable to the pensioners absorbed from Madurai (Metro), Coimbatore (Metro), Thanjavur, Karur and Pollachi Electrical Undertaking, retired before vesting date.
