2. G.O.Ms.No.375, Finance (Pension) Dept., dated 29.9.2010.

PROCEEDINGS:

In the Government Order cited, the Government of Tamil Nadu have revised the rates of Dearness Allowance payable to their pensioners/family pensioners with effect from 1st July, 2010. The Tamil Nadu Electricity Board has decided to adopt the Government Orders to the pensioners/family pensioners of Tamil Nadu Electricity Board also.

2. Accordingly, the Tamil Nadu Electricity Board directs that the pensioners/family pensioners of Tamil Nadu Electricity Board shall be paid Dearness Allowance with effect from 1st July, 2010 at the following rates:-

Date from which payable	Revised rate of Dearness Allowance (Per month)
1 st July 2010	45% of Pension/Family Pension

3. The increase in Dearness Allowance drawn from 1st July, 2010 shall be paid in cash to the Pensioners/Family Pensioners. The amount of Dearness Allowance involving a fraction of a rupee shall be rounded off to the next higher rupee if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

4. In the case of divisible family pension, the Dearness Allowance shall also be paid proportionately.


