Sub: Establishment – Encashment of Un-earned Leave on Private Affairs – Restoration orders issued – Certain clarification sought for – Issued.

In the proceedings fourth cited, orders were issued restoring the encashment of UEL on Private Affairs. It has also been ordered therein that the arrears accruing on restoration of the said benefits to those retired up to 31.1.2014 be paid in ten equal monthly instalments and the first installment has to be commenced from April, 2014.

2. Certain Superintending Engineers have sought for clarification as to the number of installments, the mode of payment to those retired/died up to 31.1.2014, for those retiring on and after 28.2.2014 and in case of death of both the pensioners/family pensioners due to restoration of the Un-earned Leave on Private Affairs.

3. It is clarified that the payment of the encashment of un-earned leave on private affairs in respect of the employees/officers retired/died after 31.1.2014 may be made in one lumpsum.

4. It is also hereby directed that

a) The said beneficiaries may open a Savings Bank Account in the respective pay drawing branch, so that the amount may be credited in the said Bank by the pay drawing authorities;

or

b) The said beneficiaries may approach the pay drawing office and the pay drawing officer will prepare 10 (ten) post dated cheques and issue the cheques to the retired staff who select this mode of payment, so that, the said beneficiaries need not come every month to get the cheque.
