In this connection, I am to invite reference to regulation 96 1 (a) of the T.N.E.B.Service Regulation and to state that one of the condition to consider promotion from A.E./Civil/ J.E./Civil I Grade to A.E.E./Civil is that they should be approved probationer in the category of A.E./Civil /J.E./Civil I Grade.

6. I therefore request you to report specifically the date of completion of probation of the A.E./Civil/ J.E./Civil I Grade without fail in the relevant column in the format enclosed.


