Sub: Extending leave on Private Affairs (LPA) – certain grievances – redressal – requested – Reg.

### Ref: Per. (CMD) TANGEDCO Proceedings No.52, dt.14.02.2014.

While thanking the respected CMD for extending the Leave on Private Affairs to the pensioners, we present few grievances faced by the pensioners for the kind attention and early redressal please.

## 1) Offices/ projects Abolished, winded off, control changed:

Due to administrative conveniences and based on the needs, many offices / projects have been abolished (or) winded off (or) controls changed. The employees who worked in such office / projects could not get the benefit of L.P.A. since they are informed to represent to the Superintending Engineers where they last worked during their retirement, which does not exist at present.

#### Solution:

# In such cases, the Chief Engineers concerned may be instructed to clear the LPA based on the last office / project they worked.

The assistance of (CIAO) audit wing may be sought to identify such circles where they already worked and to whom the SR books are attached with, based on the P.P.O. / Record available with them.

## 2) Most of the pensioners are aged and could not travel every month to Superintending Engineer's office to collect the LPA – installment cheques.

For many pensioners their residence and office last worked are at different areas and far away to travel. Even they may be in different states and districts.

After retirement employees mostly opt to reside at their native places or with their wards. Such places may be far away from their Superintending Engineer's office where they last worked.

Due to ageing many pensioners are unable to travel. Under such circumstances asking them to travel every month from their residence to office to collect the LPA - installment amount (cheque) is quite hard and practically difficult. This needs to be considered sympathetically.

#### Solution:

The Board may authorize the Superintending Engineer's to issue post date <u>cheques (for 10 months)</u> at the time of issuing 1st installment amount (cheque).

(or)

The amounts may be <u>credited directly (for 10 months)</u> to the concerned bank accounts of the individuals based on the records available with the copy of PPO / Bank Pass Book supplied by the individual.

Hence, we request the Chairman cum Managing Director / TANGEDCO to kindly consider the representation considering the health and age of the pensioners on humanitarian grounds and pass suitable orders in favour of the persons who have toiled hard in the Board during their career, please.
